- 1. The selected agency shall deploy contractual staff at ICAR-NBAGR, Karnal premises strictly as per the charter of duties and terms and conditions mentioned in the tender form. The agency shall em ploy good, reliable & robust persons with clean track record to carry out the job contract. In case a ny of the personnel so supplied by the agency is not found suitable by the Institute, the institute sh all have the right to ask for its replacement without giving any reasons thereof and the agency shall on receipt of a written communication in this regard will have to replace such persons immediately. As on date, the approximate requirement is attached in **Annexure-II**. However, the actual number of deployment shall be communicated at the time of award of contract & payment shall be made on actual engagement on pro rata basis.
- 2. Service providers should have a registered office/branch at the State of consignee location. Valid documentary proof of the same should be attached with the bid
- 3. - 4. However taxes which are as per the rules of the Govt. of In dia shall be deducted at source from monthly bills of the successful tenderer, as per rule. The pay ment shall be made to the firm after satisfactorily report of work from the Security In-charge.
- 25. **TERMINATION**: This contract can be terminated by giving one month's notice on either side and t hat any notice required to be served shall be sufficiently served on the parties if delivered to them personally or dispatched by the address herein given under registered post or through e-mail. The ICAR- NBAGR, Karnal will have no responsibility for any loss / damage caused to them. This also ca nnot be challenged through any court of law.
- 26. **LOSS AND / OR DAMAGES**: In case of any loss or damage done to the property of the ICAR- NBA GR, Karnal by personnel provided by the agency for security duties at ICAR- NBAGR, Karnal, full da mages will be recovered from the Agency and decision of the Competent Authority of ICAR- NBAGR, Karnal shall be binding on the agency. In case of any loss incurred by the institute on account of I

apses on the part of the security personnel provided by the agency, full recovery of the losses will be made from the firm and decision of the Competent Authority of this Institute will be final in this regard.

- 27. **SECURITY DEPOSIT**: **An amount equal to 5% of the total contract value** shall be deposited by the engaged agency as security money / performance guarantee within three weeks from the a ward of the contract. The security shall be refunded to the contractor after satisfactory completion of the contract or adjusted against any damages or loss of property, etc. caused by the personnel deputed by the agency. No interest will be paid on the security money deposited with the ICAR- N BAGR, Karnal. However, in case of any breach of conditions of the contract, the performance security is liable to be forfeited.
- 28. **BID VALIDITY**: The quoted rates must be valid for a period for 90 days from the last date of submi ssion of the bid. The overall offer for the assignment and price quoted by bidder shall remain unch anged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.
- 29. In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason ther eof. The tenderer should also be ready to extend the validity, if required, without changing any ter ms. conditions etc. of their original tender.
- 30. In exceptional circumstances, the ICAR NBAGR may request the bidders' consent for an extensio n of the period of bid validity. A bidder may however be at liberty to refuse the request without risk ing forfeiture of his earnest money. A bidder agreeing to extend the validity of bid will not be allow ed to modify its bid.
- 31. Anyone or more of the following action / commission / omission are likely to cause outright rejection of tender:
 - Any BID / EMD received late without conclusive proof that it was delivered before the spe cified closing time.
 - · Any conditional bid or bid offering rebate.
 - Any bid in which rates have not been quoted in accordance with the details specified in the e Bid Documents.
 - Any effort by a bidder to influence the ICAR NBAGR in the bid evaluation, bid compariso n or contract award decision.
- 32. **INTERPRETATION**: All the terms and conditions of contract shall be read in conjunction with all ot her documents forming part of this contract. Notwithstanding the subdivisions of the documents in to these separate sections, every part of which shall be deemed to the supplementary to and com plementary of every part and shall be read with and into the contract.
- 33. **ARBITRATION**: Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement or matter whatsoever, shall before /after completion or abandonment of work or during extended period, hereafter arises between the parties, as to the meaning, operatio n or effect of the contract or out of or relating to the contract or breach thereof, shall be referred t o a Sole Arbitrator to be appointed by the Director, ICAR - NBAGR, Karnal. If the arbitrator to whom the matter is originally referred dies or refuses to act or resigns / withdraws for any reason from th e position of arbitration, it shall be lawful for the ICAR - NBAGR to appoint another person to act as Arbitrator in the manner aforesaid. Such person shall be entitled to proceed with reference from th e stage at which his predecessor left it, if both the parties consent to this effect, failing which the A rbitrator shall be entitled to precede de novo. It is a term of the contract that the party invoking ar bitration shall specify all disputes to be referred to Arbitrator at the time of invocation of arbitratio n under this clause. It is also term of the contract that the cost of arbitration shall be borne by the parties themselves. The venue of arbitration shall invariably be at Port Blair. Subject as aforesaid t he provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-en actment thereof or rules made there under and for the time being in force shall apply to the arbitra tion proceedings under this clause.
- 34. **FORCE MAJURE**: If at any time, during the continuance of this contract, the performance in whole or in part by either party, of any obligation under this contract, shall be prevented or delayed by re ason of any floods, explosions, epidemics, quarantine restriction or act of God (hereinafter referred to as events), provided notice of happenings of any such eventuality is given by either party within

7 days from the date of occurrence thereof, neither party shall be due to reason of such event be entitled to terminate this contract nor shall either party have any such claim for damages against the other respect of such non – performance or delay in performance. The operation of contract shall be resumed as soon as practicable after such event may come to an end or cease to exist and the decision of the ICAR – NBAGR as to whether the operation have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or in part of any obligation under his contract is prevented or delayed by reason of any such event for a period exceeding 90 days either party may at his option terminate the contract. Provided, also that if the contract is terminated under this clause, the ICAR – NBAGR shall be at liberty to take over from the Security Agency, the security personnel, vehicles & equipments deployed in the campus until a new security agency is appointed and commences the operation.

35. COMPARISON OF BIDS:

- 35.2 If more than one bidder happens to quote the same lowest price, ICAR NBAGR, Karnal reserves the right to decide the criteria and further process for awarding the contract, decision of ICAR NB AGR, Karnal shall be final in awarding the contract.
- **36.**The contractor is advised to have a complete survey of campus & farms of ICAR- NBAGR, Karnal do ne before offering its rates.
- **37.**No Union activities of such workmen shall be allowed in the institute premises and no such Union or any other Union shall be recognized by this institute for any intent or purposes. The contracting fir m shall ensure that the grievances of its workmen are resolved at its own level and no correspond ence from any of its engaged personnel may be entertained by this office except in case of violation of statutory provisions.
- **38.**No child labour to be deployed and equal wages to be paid irrespective of gender of the workmen.
